- The Client understands that Cathy Daugaard of Family Dog Training will provide services in a reliable, caring and trustworthy manner and do all in her ability to keep the pet safe, secure and healthy while in her care. By signing this contract, Owner agrees that life is full of surprises and promises in consideration of these services and as an express condition thereof to expressly waive and relinquish any and all claims against Cathy Daugaard and FDT, its employees and agents, except those arising from negligence or willful misconduct. In the event of inclement weather or natural disaster, Cathy Daugaard, FDT, its employees and agents are entrusted to use best judgement in caring for your pet and will be held harmless for consequences related to such decisions.
- Dogs participating in physical exercises may be injured by running, jumping, etc. and owner accepts this risk and agrees to pay all veterinary costs. All dogs are trained or otherwise handled or cared for without any liability whatsoever for loss or damage from disease, death, running away, or theft. All behavioral advice and training suggestions are provided at the client's own risk-use of this information is voluntary. The dog's behavior now and in the future is the sole responsibility of the owner, who agrees to pay for any and all damage or injury resulting from the dog's behavior or it's failure to respond to commands, and absolves FDT, Cathy Daugaard, et al. from any and all obligations to pay such damage.
- All pets must be vaccinated. Despite these precautions, Owner acknowledges that the Owner's pet will be in an environment with other pets and understands that any pet may harbor and spread a communicable disease. The owner releases from and waives all claims and liability against FDT and Cathy Daugaard for, all losses, damages, costs and expenses arising out of or in connection with any communicable disease contracted by the Owner's pet during boarding.
- If the pet is not picked up as agreed, FDT will give written notice to the owner by Certified Mail to the address shown on the contract. The client understands and agrees that if the owner does not respond within 10 business days, Florida Law deems the pet to be abandoned. Owner understands and agrees that the pet then becomes the property of Cathy Daugaard and FDT to keep, sell, surrender, give away, or euthanize at her sole discretion. The owner remains liable and agrees to pay all fees and costs, including but not limited to boarding, training, veterinary and collection costs.
- All returned checks will result in a charge of \$25, if the face value does not exceed \$50; \$30, if the face value exceeds \$50 but does not exceed \$300; \$40, if the face value exceeds \$300; or an amount of up to 5 percent of the face amount of the check, whichever is greater. The client agrees to pay all court, attorney, and collection fees.
- Family Dog Training is not responsible for loss or damage to pet bedding or toys.
- Departures after 4 p.m. are liable for an additional day.
- **Medical Authorization : Should medical attention be necessary, Cathy Daugaard of Family Dog Training and it employees and agents are authorized by my signature below to seek medical treatment for my pet(s). I agree to be monetarily responsible for any debt incurred involving any and all medical treatment of my pet(s). I release Cathy Daugaard and FDT, and its employees and agents from any responsibility for claims or debts related to injury or medical treatment, including transportation to and from the veterinary clinic.**
